### Project Description

1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

To place life saving AED's (Automated External Defibrillators) in and around public places in our community. This simplified grant will provided us with the funds necessary to purchase three (3) AED units and install them at Kiwanisland Park, the Festival Amphitheatre and the Gem Theatre.

Dr. Bill Annan and myself originated the program, have performed all the research as well as contacting the various local and state emergency and health care agencies for approval. We also researched all the various manufacturers of these AED's so as to determine the best units for our needs. In addition we make the discretionary determinations as to where these units will be publicly placed to make the most impact upon public safety. We then make the connections with the recipient organizations and coordinate their training and certifications with the Fire Department. We have also set up joint training sessions with our other Rotarian members and their families in the use of these units and in cardio-pulmonary resuscitation.

5. What are the expected long-term community impacts of the project?

We are working towards placing as many of these life saving devices in and around the community as we can. Sudden cardiac arrest happens approx 1000 times a day in the U.S. and these AED's are proven to save lives when applied to the victims within 4-6 minutes following arrest. We would like to become, like Seattle was in the 80's with the implementation of their comprehensive city wide citizen trained CPR program, the safest place in the country to suffer a cardiac arrest in.

6. If a cooperating organization was involved, what was its role?

The Garden Grove Kiwanis Club as well as the two theatre troupes were involved in both the receipt of the AEDs as well as participating in a joint CPR/AED training session put on by the Garden Grove Fire Department. The training was provided to insure that several members from all three recipient organizations are trained in cardio-pulmonary resuscitation and Automated external defibrillator use and will be ready to act if and when the situation arises.
