The Club will partner with OC Special Spokes to fit children of special needs with tricycles to provide increased mobility so that they may better engage others in their neighborhood, increase communication and self esteem while boosting their overall health and fitness. Each adaptive tricycle will cost up to \$900. We plan to provide five such tricycles. Rotarians will assist in coordinating the fitting and parental orientation with the physical therapists.
