Dick,

We just found out the kiln arrived in the warehouse at the beginning of February. Before we placed the order we had requested the kiln be delivered to Sun View to be used this year knowing that the required voltage would have to be addressed. Our facilities department made the decision to wait for the kiln to arrive before installing the needed voltage. As time went by and we got closer to moving back to Westmont it was felt that it would not make sense to install it at Sun View(our interim campus) and then move it several months later. The whole situation is unique and not one I have dealt with before. I think the mix up in our purchasing department holding the order for so long and then the long order time with the manufacturer and then the short time before moving back has made having the kiln this year nonexistent. It's embarrassing on our part to not have been able to start using this expensive and thoughtful donation. I'm so sorry that you even have to ask.

If you need me to explain to someone what happened to the kiln this year I would be happy to. Please know that your generous donation will still be used with your participation once we get it to its final destination. I have seen the location it will be installed at Westmont and have been assured the voltage has already been taken care of. We want to start using it as soon as possible.

Again, I am so sorry this has turned into such an ordeal. We really do appreciate your support this year.
