- Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?  
The STEM class at Cerro Villa Middle School with instructor Daniel Baker as lead built a full scale model of the Wright Brother's Test Glider (about 32 foot wingspan). The school's math and science departments calculated the lift of the wings, the history department studied the history of flight, the English department and the CVTV club creted a powerpoint and video documenting the project. The largest part of the project was construction efforts led by students in the Maker's Club at Cerro Villa.
- How many Rotarians participated in the project?

A few Rotarians were involved in the metal fabrication, examining the schematics and finding resources to get parts built. Many rotarians visited the kite/glider at various stages of construction and learned about techniques used to bend wood, lash the pieces together, and place cloth over the entire wing surfaces.
- How many non-Rotarians benefited from this project? about 300 students learned a variety of lessons as described above
- What are the expected long-term community impacts of the project?  
The kite/glider project has been presented at the City Hall as part of a Villa Park City Council meeting. Students will continue learning from the project for many years, as all pieces are retained and can be re-assembled.
