Project Title: Scholarships for Class of 2021

Project Description

1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

The Keller Independent School District (ISD) serves more than 35,000 students in portions of the cities of Colleyville, Fort Worth, Haltom City, Hurst, North Richland Hills, Southlake, Watauga, Westlake, and the entire City of Keller. Keller ISD has six campuses serving more than 11,000 students, including four traditional high schools, one alternative high school, and a Career and Technology Education (CTE) Center.

As higher education costs continue to rise, many students have a difficult time finding ways to pay for college. The Rotary Club of Keller provides six \$1,000 scholarships to high school students in Keller ISD who are well rounded and live out the Rotary Club's motto of "service above self." By providing scholarships to graduating seniors, the Rotary Club of Keller supports the school district and Keller ISD Education Foundation in their efforts to remove barriers to applying and paying for college.

2. How many Rotarians participated in the project? 6

3. What did they do? Please give at least two examples.

Rotarians served as a sub-committee on the Keller ISD Education Foundation and Keller ISD CTE scholarship committees. As subcommittee members, they reviewed and scored all of the applications for the Rotary scholarships. Based on their scores, six students received \$1,000 scholarships from the Rotary Club of Keller.

The Rotary Club of Keller president, Jackie Black, participated in the in-person senior awards ceremonies at each of the four traditional high schools in Keller ISD and in the virtual scholarship event for the CTE department. At each event, Ms. Black represented the organization and announced recipients of the Rotary Club of Keller scholarships.

4. How many Non-Rotarians participated in the project? 20

5. What are the expected long-term community impacts of the project?

By providing scholarships, the Rotary Club of Keller is investing in the educational pursuits of young people in our community. Our long-term goal is that these students would complete their education and bring their knowledge back to the Keller community. It is also our goal that these young people will start careers and invest in the community.

6. If a cooperating organization was involved, what was its role?

The Keller ISD Education Foundation and Keller Independent School District are involved. These organizations oversee the application and selection process. The Keller ISD Education Foundation also follows up with scholarship recipients and sends payments to their chosen educational institution.
