## **Project Description:**

- 2. Briefly describe the project. What was done and where did the project activities take place? Explain how the beneficiaries and other community members were involved?

Funds were granted to the North Fort Collins Business Association (NFCBA) Coats and Boots program. This program provides high quality winter coats and boots to Poudre School District (PSD) elementary school students in low-income families. PSD staff and teachers determine which students qualify and distribute the clothing. The beneficiaries are elementary school students and their pictures are not allowed to be taken. Depending on availability JAX Outdoor Gear, Scheels, or other stores provide clothing at greatly reduced prices. NFCBA staff and Rotary club members delivered the clothing to the schools.

3. How many Rotarians participated in this project? Fran Lefler and his wife Nancy from the Rotary Club of Fort Collins Breakfast helped deliver the clothing. According to Don Butler, NFCBA, other Rotarians (from other clubs) helped with the delivery but he did not remember the number of people or names.

- 4. What did they do? Please give at least two examples. The Rotarians helped load the clothing that was purchased from the stores into vehicles. The Rotarians traveled with NFCBA staff to the school and helped unload the clothing into the school. Neither NFCBA staff nor Rotary members were allowed to interact with the students receiving the clothing.
- 5. How many non-Rotarians benefited from this project? The project (\$2,400) benefited 38 elementary school students and their families specifically Putman Elementary. In total the Coats and Boots project benefited 940 elementary school students from low-income families in 28 PSD schools.
- 6. Who are the beneficiaries and what is the expected long-term community impact of this project? The beneficiaries are 38 elementary school students and their families (low-income families). The long-term impact is that the children will have high quality winter coats and boots for at least two years (sizes are chosen to be a bit large so that they can be worn for at least two years). After these children outgrow the clothing, the clothing can be passed on to younger family members. The clothing makes it more enjoyable for the children to attend school and increases their participation in learning and socializing.
- 7. If a cooperating organization was involved, what was their role? The North Fort Collins Business Association developed the Coats and Boots project and arranged for the clothing and delivery date.
