The Rise Against Hunger food packaging event produced 10,000 packaged meals in 2 hours on April 29, 2023 at the Rotary District 5320 Office in Orange, Ca.

Nine Rotarians were joined by 25 volunteers.

Food packages will be sent to where needed. Currently shipments are going to the Philippines, South Sudan, Uganda and to emergency aide relief for Ukraine.

We worked with Rise Against Hunger, an international hunger relief non profit. They supplied the basic materials, coordinated the packaging and will followed up with the distribution of the food packets to people facing hunger around the world.
