Single use consumable protective equipment.

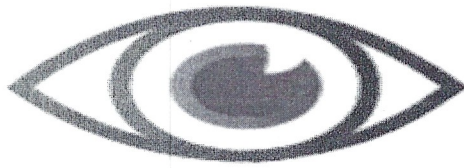
