The Josh the Otter Water Safety Program teaches young children the importance of water safety and how to safely be around water. Funds were used to purchase the educational materials for the program and Rotarians went to schools in the North Valley and conducted interactive sessions with classrooms of young kindergartners and elementary schoolers to teach about water safety.
