We will provide 300 students with school supplies to replenish supplies in their backpacks. Students traditionally receive a backpack and supplies at the start of the school year. This will give us the opportunity to provide Title I students with school supplies for the remainder of the school year. The assembly of supplies took place at the Lakewood Family Y. ASES-funded elementary schools in the ABC School District where students benefitted from the school supplies.

2. How many Rotarians participated in the project? 22.

4. How many non-Rotarians benefited from this project? 333 students and an additional 17 volunteers.
