- Insurance, Risk Management, or Law

Must be a full time (12 credits minimum) student during the Fall 2024 semester (Please submit current or future schedule with application)

Must be enrolled in at least one 3-credit degree-related course for Fall 2024

Must have a minimum 2.5 GPA for the prior full-time semester.

Must submit a brief essay describing educational and career plans and outlining why you are deserving of this scholarship award. Essay must be prepared using Microsoft word processing, double-spaced, 12 font, one page with traditional 1" margins and headers, and email attached to this application form. *Please include any insurance affiliations including internships, part-time or full-time positions in the insurance field, aligned with career interests related to insurance, etc.*

Please put "**CPCU Scholarship Application**" as the subject of your email to assure prompt handling. Applicants will be evaluated based upon all the information provided in the application. *Recipients will be announced November 1, 2025.*
