

## Project Phaino Grant Application Information

### *Project Description*

#### **Use of Funds**

The funds will directly support the ongoing outreach efforts of Project Phaino, which currently hosts five monthly outreach events aimed at serving individuals in our local community who are experiencing housing instability and poverty. Our efforts focus on providing both practical resources and relational support, creating spaces of dignity, care, and connection.

Specifically, the funds will be allocated as follows:

#### *Outreach Events*

- **3 Monthly Shower Outreaches (approximately 120 served each month spread across three outreaches):** Three times a month, we partner with existing community programs at local host sites to offer access to our mobile shower unit.
- **Downtown Fullerton Meal Outreach (80 served at event):** A full meal is prepared and served to the community.
- **Third Saturday Outreach (100 served at event):** Our largest event, offering a wide array of services including:
  - **Feet washing**
  - **Haircuts**
  - **Manicures**
  - **Clothing giveaways**
  - **Prepared meals**
  - **Live music**
  - **Encouraging messages from guest speakers**
  - **Showers**

#### *Supplies & Program Needs*

We are applying in the amount of \$2000 to help fund the following:

- **Hair Cutting Station:** Updated clippers, combs, sanitizing solutions, capes, and hair products.
- **Feet Washing Station:** Lotion, soap, nail files, clippers, polish, gloves, and towels.
- **Clothing Station:** T-shirts, pants, belts, shoes, socks and underwear and new seasonal items (e.g., jackets in winter).
- **Kitchen Station:** Disposable aluminum pans, gloves, spices, cleaning products, funds for general meal service needs.
- **Shower RV:** DMV registration, vehicle maintenance, fuel, insurance and cleaning supplies.
- **Miscellaneous Outreach Needs:** Signage, tables, setup supplies, and storage costs.

### **Impact on the Community**

This project provides more than just immediate relief—it fosters **community, dignity, and hope**. Our outreach efforts:

- Address **basic human needs** through meals, hygiene services, clothing and emotional support through community.
- Offer a **compassionate, consistent presence** that builds trust with individuals facing instability.
- Create opportunities to **listen, understand, and support** people as they navigate challenges such as loneliness, unemployment, or housing insecurity.
- Help individuals take steps toward healing and stability through personal connection and tailored support.

### **Timeline & Scope**

This is an **ongoing** initiative that takes place monthly throughout the year. The need for community care and practical assistance is ever-present, and this funding will enable us to **sustain and expand** our impact as we respond to both immediate needs and long-term community healing.
