

The Mission Central Family Opportunities Program (FOP) provided case management and financial support to the following six families with funding from the Rotary Club District grant. Each of the families listed were in need of short-term immediate assistance and are now more financially stable. The family dynamics are as follows:

- A family was being evicted and preparing for court. We paid \$1046 in back rent to stop the
  eviction process and \$680 to help the family get current on rent. Now one adult in the family is
  working part-time and maintaining the monthly rent.
- A mother had to leave an abusive situation in San Antonio immediately and relocated here to
  the HEB area. Her family was doubled up with another family in a small unit and had to find
  housing of their own quickly. We assisted the family with \$1000 for the deposit and partial first
  month of rent to get them into a rental property two weeks after the mother secured
  employment in the area.
- We assisted a family that was currently residing in a motel and had run out of unemployment funds. The family had already spent two weeks in their vehicle during the prior month until someone graciously paid for a couple of nights at the motel. The father recently received a job offer and started work the day before entering into FOP. He was scheduled to get his first paycheck two weeks later but needed assistance until then. He was in a single room at the motel with his wife and two children. We assisted the family with two weeks of stay which totaled \$542. This allowed the family to continue with a residence until the father received his first pay check.
- A grandmother was raising her grandchild and lost her job in December 2014. She was receiving
  unemployment but it was not sufficient to cover her monthly bills. She was currently one month
  behind in her rent in the amount of \$950. We paid the one month's rent and she was fortunate
  enough to secure employment before the next month of rent was due.
- We were able to assist another family that was sitting outside of a motel because they had run
  out of funds for the week. The father is working but had only worked a few days in the past two
  weeks because business was slow. This resulted in them becoming homeless. We paid for a two
  week stay in the amount of \$554 which assisted the family with housing stability until his work
  hours picked back up and he was able to pay for the room again on his own.
- We worked with one mother who was unemployed since November 2014 and unable to pay her
  utility bill and a portion of her rent. She was hired for a position shortly after enrolling into FOP
  but was not starting for three weeks because of the lengthy background investigation and
  training schedule. We assisted with the partial rent and were able to get the utility bill paid
  through another agency. Total assistance provided to this family was in the amount of \$229.
