Marine educational experiences for 345 children (four 4th grad classes & two 2nd grade classes) from 4 different OC area elementary schools (including transportation). See file attached Adopt-A-Class Summary from the Ocean Institute (2015Summary.pdf)

2. How many Rotarians participated in the project?

6 San Clemente Rotarians participated.

3. What did they do? Please give at least two examples.

The Rotarians were primarily chaperones & hosts documenting with photo imaging, etc. ... as the Ocean Institute staff conducts all the cruises, classes and lab work.

4. How many non-Rotarians benefited from this project?

Approximately 360 non-Rotarians, as each class brought teachers & aids in addition to the kids.

5. What are the expected long-term community impacts of the project?

Most of these kids had never been on a boat before, while many had never even seen the ocean up close or at all! The teachers describe the experience as "life altering for these kids" as their world is expanded ... especially when the institute staff talks about careers in Marine Biology and other ocean-related vocations.

6. If a cooperating organization was involved, what was its role?

The Ocean Institute of Dana Point provides all the facilities, boats, classes, laboratories and teachers ... in addition to all the coordination with the school districts to enable the visit.
