1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

On November 14, 2015 the Rotary Club of Laguna Niguel provided a dental clinic to third graders residing in Laguna Niguel. The dental clinic was held at Niguel Hills Middle School, The objective of the project was to provide Dental service to the children of low income families who did not have dental insurance and could not afford dental care for their children.

- 2. How many Rotarians participated in the project? Eighteen Rotarians participated volunteered and participated in the project
- 3. What did they do? Please give at least two examples.

Rotarians sent out an announcement to all of the Laguna Niguel elementary school principals to provided information concerning the project. Rotarians checked out various schools to find the best possible accommodations for the children and the dental professionals Additionally, Rotarians provided assistance to the parents by signing up their children and completing the health history and other required paperwork. Rotarians also provided numerous support services on the day of the project to the professional dental staff and children, including coordinating arrangements for coffee, providing a free breakfast from MacDonald's and providing a discounted lunch from Subway to the dentists who worked that day.

- 4. How many non-Rotarians benefited from this project? 85 third graders and adults for a total of \$43,715 in professional services.
- 5. What are the expected long-term community impacts of the project?

The Rotary Club of Laguna Niguel is involved with the surrounding community and is interested in projects and ways to provide assistance to those families who need a little extra help. The Rotary Club is particularly interested in promoting health of the children of families needing additional assistance. Since the focus of the project is on the children, the expectation is is that the dental clinic will have a positive impact on the community and their families. Such an experience provides a much needed service and promotes goodwill throughout the community. The entire community benefits from such an experience.

6. If a cooperating organization was involved, what was its role? AYUDA is a 501c(3) organization providing dental care to the underserved.
