# 1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

#### Project:

The Rotary Club of Lakewood is pleased to support a High School Scholarship Program. This program is open to students who are graduating from a Lakewood area high school and are planning to continue their education beyond high school.

These scholarships seek students who have overcome adversity or challenges in receiving their high school diploma; have exhibited good citizenship and respect for human values; have assisted in some way in making their community a better place in which to live; and have a sincere desire to complete a post-high school education.

# The following work was completed to offer this program in the Lakewood community.

- 1. A member of the club was selected to chair the program
- 2. The Chair created a scholarship application form

#### When and where the project took place.

- Club members participated in annual fundraiser in July 2015 and determined how much could be allocated to support scholarship awards.
- 2. Lakewood schools were notified of the scholarship opportunity in April 2016
- 3. Student applications were received in May 2016
- 4. Three club members reviewed all applications to select award winners
- 5. Present the scholarship awards at a regularly scheduled club meeting on Thursday, May 19
- 6. Make a presentation to the student at their schools' Award Night or graduation.
  - ✓ St. Joseph High School on Friday, May 27th at 1:00 p.m.
  - ✓ Artesia High School on Wednesday, June 1st at 6:00 p.m.
  - ✓ Mayfair School on Tuesday, June 7th at 6:00 p.m.

#### Beneficiaries.

Six high school seniors were selected to receive a \$700 scholarship from the club. The winners, along with two guests and a representative from their school were recognized at a club meeting on Thursday, May 19. The students, their supporters including family and educators, and the greater Lakewood community benefit from supporting these students as they aim for higher education.

37 active members.
