- A. All parties affirm that Global Grant #GG1523876 is initiated, controlled, and managed by the Rotary clubs and/or districts involved in the project.
- B. Rotary Club of Prishtine International and Rotary Club of Kona Sunrise affirm that Water for Life Kosovo is reputable and responsible and acts within all governing laws of the project country.

- B. Supervise the installation of three (3) sanitation systems in identified schools
- C. Train maintenance personnel for all systems, and check this is done on a regular basis

6. ROTARY CLUB OF KONA SUNRISE SHALL:

- A. Coordinate the raising of funds for the schools project in Kosovo
- B. Coordinate with RCPI for the disbursement of funds
- C. Receive 3 monthly updates of the work progress

7. WATER FOR LIFE KOSOVO SHALL:

- A. Train qualified local personnel in hygiene education training
- B. Supervise an ongoing hygiene education program in the schools
- C. Receive regular updates from the schools about their hygiene education programs

8. MODIFICATION

Modifications within the scope of this document shall be made by mutual consent of the parties, by the issuance of a written modification, signed and dated by all parties, and approved by The Rotary

Foundation prior to any changes being performed.




